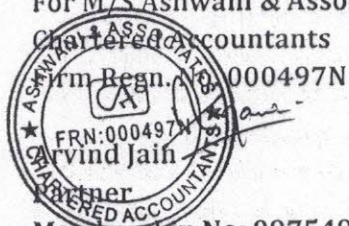
Sir,





